 - e. Mothers' Group (Presented by Karen Ruppanner): Very successful Feb 28th at Perry's for dinner. May 15th is next event. Last kids play date was cancelled due to rain. Rescheduled April 28th 11:30-1 at Skunk Hollow.
 - f. Social Committee (Presented by Karen Ruppanner): Egg hunt is the next event on April 20th at 9am (hunt starts at 9am sharp). Reserved the park for that day. Need volunteers to help setup and for egg hiding around 8:15am. Will set up membership and donation box on coffee table. Bess is hosting an egg stuffing party April 3rd at 10am.
 - g. NRG (Bill reporting based on Suzie Beatie's email): Spring Drill was a success with Marina Village participation. Radio usage is getting better. New paid coordinator for all NRGs across the central Marin neighborhood groups. April 3rd (7-8:30) is the next event at Cove School for a Fire Safety Talk by the Central Marin Fire Marshall. - j. Treasury (Presented by Kate Castonguay): Presented financial statements. Made adjustments to the budget allocations based on historical trends. Voted to approve adjustments. Kate to send out summary of changes. Will review at the June meeting.
- k. Town Liaison (Presented by Carol Berg): Town is reluctant to approve cannabis sales for many reasons. Discussion of adjustment to election date as dictated by state laws. Leash laws have been discussed, but will be deferred for now. Presentation on the Intergenerational Center, including recent recognition. Presently 225 members. Question from Board about the next steps for the dual-stream recycling program. Follow-up with Bob next meeting.
